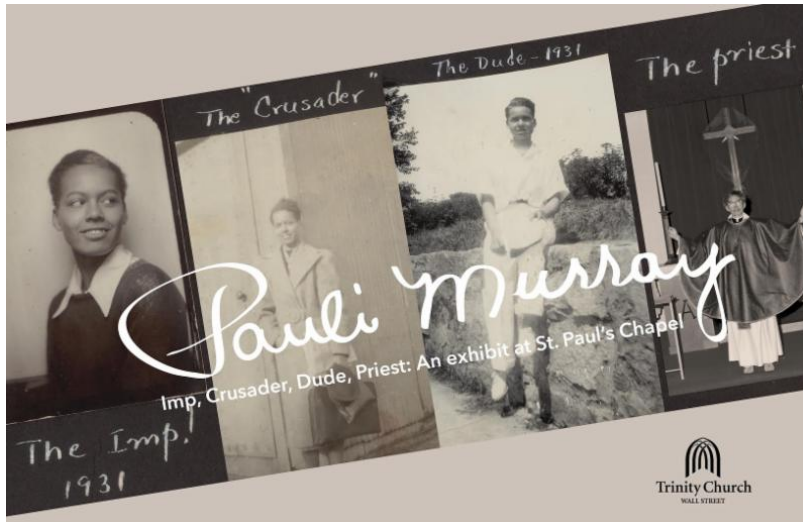

## Pauli Murray Exhibit Opens in NYC

*Pauli Murray: Imp, Crusader, Dude, Priest* is an interactive exhibit chronicling Pauli Murray's life and legacy as a brilliant 20th century human rights activist, educator, lawyer, poet and Episcopal priest. The exhibit explores Murray's multifaceted identity and how she aspired to an integrated body, mind and spirit and a life of purpose and transformation. Developed in collaboration with the Pauli Murray Project at the Duke Human Rights Center@FHI and the Pauli Murray Center for History and Social Justice, *Imp, Crusader, Dude, Priest* will be hosted at St. Paul's Chapel in New York City by Trinity Church Wall Street and presented alongside self-portraits from the students at Leadership and Public Service High School.

An [opening reception](#) will be held at St. Paul's Chapel from 6-8 pm on March 1, and the exhibit will be on display through March 21.
